# **Current Education Programs**

## Chapter 30 / Montgomery GI Bill® \*\*

- Who Veterans honorably discharged, 2 years active service after June 30, 1985
- What Up to 36 months of financial assistance for educational pursuit

When – Can be used up to 10 years from last date of service Where – Can be used at approved programs to include colleges,

where – Can be used at approved programs to include colleges, vocational/technical schools, correspondence courses apprenticeships/on-the-job training, flight training, and tech training.

## Chapter 35 / Dependents Education Assistance (DEA) \*\*

- Who Benefit is used by dependent children and dependent spouse
- What Up to 36 months of financial assistance for educational pursuit
- When The dependent children will use this benefit between the ages of 18-26 years old and is valid for 10 years. The dependent spouse can use this benefit up to 20 years after they become available.
- Where Can be used at approved programs to include colleges, vocational/technical schools, correspondence courses apprenticeships/on-the-job training, flight training, and tech training.

### Chapter 1606 / MGIB Selective Reserve \*\*

- Who Benefit is used by Veterans that served in the Selected Reserves/National Guard.
- What Up to 36 months of financial assistance for educational pursuit
- When The Veteran has a 6-year obligation of service required to be eligible for this benefit.
- Where Can be used at approved programs to include colleges, vocational/technical schools, correspondence courses apprenticeships/on-the-job training, flight training, and tech training.

Note:

\* Denotes program where school will receive direct payments of tuition and applicable fees. Veteran will receive a monthly housing allowance and book/supplies stipend.

\*\* Denotes program where veteran will be paid a direct stipend only. The veteran will be responsible for paying their tuition and fees directly to the school.

## Chapter 33 / Post 9/11 GI Bill® \*

- Who Veterans honorably discharged, who served at least 90 days active duty.
- What Up to 36 months of financial assistance for educational pursuit. Benefit includes a stipend Cost of Living allowance and payment for the education program which is determined by the amount of time of service on active duty.
- When The Veteran served on active duty on or after 9/11/2001. Veterans that served after 1/1/2013, there is no expiration date for this benefit.
- Where Can be used at approved programs to include colleges, vocational/technical schools, correspondence courses apprenticeships/on-the-job training, flight training, and tech training.

Member Serves	Percentage of Maximum Benefit Payable
At least 36 months	100%
At least 30 continuous days on active duty and must be discharged due to service-connected disability or received a Purple Heart	100%
At least 30 months, but less than 36 months	90%
At least 24 months, but less than 30 months	80%
At least 18 months, but less than 24 months	70%
At least 6 months, but less than 18 months	60%
At least 90 days, but less than 6 months	50%

## Additional Employment Based Training / Resources

### Chapter 31 / Veterans Readiness & Employment \*

- Who Veterans honorably discharged that have received a disability rating of 20% or higher
- What Veteran will receive up to 36 months of financial assistance for education pursuit
- When Veteran would apply for this benefit through the Veterans Administration
- Where This program will be approved at the Veterans Administration

### Veteran Rapid Retraining Assistance Program (VRRAP) \*

- Who Veterans age 22-66, must be unemployed due to COVID-19 and may not be receiving unemployment or eligible for any other VA education benefits.
- What- Education and training approved under the GI Bill® that leads to high demand jobs. This includes up to 12 months of tuition and fees, along with a monthly housing stipend.
- When Current program set to cease accepting new applicants on December 11, 2022, or when the \$386M funding limit has been reached
- Where Can be used at approved GI Bill® schools/institutions
